| Rationale                                 | A sensitive measure of health in the perinatal period. Also important indicator for quality of perinatal health care, and preventive care.   |
| Remarks                                   | <ul> <li>The WHO recommendation for international comparisons is to include live births and stillbirths with a weight of 1000 grams or more. This is only to minimize the variation in registration criteria (the registration of live births with very short gestation may vary between countries), but this is not very relevant for the EU any more due to improved survival of children weighing less than 1000 grams.</li> <li>PERISTAT is an EU-funded project on evaluating and monitoring perinatal health in Europe. PERISTAT recommendation, which is scientifically preferable, is: The number of fetal deaths and deaths in the early neonatal period (up to 6 completed days after birth) after live birth (weighting 500 grams or more) at or after 22 complete weeks of gestation in a given year, expressed per 1000 live and stillbirths in the same year. PERISTAT has data only for years 2000 (15 countries) and 2004 (26 countries). Next data round is planned to be for 2010 data.</li> <li>PERISTAT plans in the next phase to explicitly work on integrating their recommendations</li> </ul> |
